MUSAWA Publishes Eye on Justice (22)

MUSAWA announces the publication of issue no. (22) of Eye of Justice, where MUSAWA documents the daily performance of the justice complaints system, the MUSAWA receives regarding law-violations, the legal which memos through **MUSAWA** addresses the relevant authorities to demand the cancellation of anything contradictory to the rule of law, and the authorities' response to these memos.



MUSAWA Launches a Training Program to Build the Capacities of the Grassroots Organizations in Monitoring and Documentation of Violations

MUSAWA organized, during July, a training program to build the capacities of the grassroots organizations in the field of receiving complaints and the monitoring and documentation of violations. The training targeted the staff and volunteers



of a group of grassroots organizations from the various localities of Gaza Strip with whom Musawa has memorandums of understanding. The training program was commenced by the Legal Monitoring Officer at MUSAWA, Adv. Rula Moussa. Eighty participants, including fourty five women, attended the training that focused monitoring and documentation of violations as well as submiting complaints mechanisms. More details here.

MUSAWA and Press House-Palestine Organize a Roundtable Discussion on the Right to Access to Information and Mechanisms of Legal Protection

MUSAWA and Press House – Palestine organized a round-table discussion, entitled: "The Right to Access to Information, and the National and International Mechanisms of Legal Protection". The workshop, which was attended by 25 participants, including 10 women, is part of the extended community workshops that aim at ensuring the conformity of national legislation with international agreements.

The workshop concluded with recommendations to establish a mobile legal clinic that provides legal support and consultation to media professionals, in addition to assining a Deputy Prosecutor and a Judge within the Palestinian courts to tackle cases related to journalism and freedom of speech, as a first step until the establishment of courts specialized in media-related cases. The participants also recommended increasing pressure to pass the law on the right to access to information. More details <a href="heterogeneering-neerin



MUSAWA Organizes a Training Course in Ramallah: "Introducing Intellectual Property: Means of Protection"

Given the importance of intellectual property as an integral part of academic freedom as well as the freedom of expression stipulated in the Basic Law, MUSAWA organized a third training course about this issue to raise awareness among trainee and recently licensed lawyers. The training, attended by 18 participants, including 14 women, was held at MUSAWA's headquarters in Ramallah.



The training courses tackled the definition of intellectual property and the national, international, and regional legislation regulating intellectual property; national and international patents and trademarks; civil and criminal protection of intellectual property; and the role of the World Intellectual Property Organization (WIPO) in resolving intellectual property disputes.

Legal Memos

11/07/2018 – Memo to the Anti-Corruption Commission about Depositing Public Officials' Gifts in the Public Treasury and the appointment of the daughter of the Supreme Judge in his office with the position of "Manager, Grade C".

12/07/2018 – Reminder to the Anti-Corruption Commission to respond to MUSAWA's memo on "The failure to enforce final ruling to annul retirement decision", which was sent a month before the date of the reminder. MUSAWA's Interventions

During July, MUSAWA received six complaints:

1) Imprisonment until acquiescence; 2) Exploitation of a position and hiring without respecting the legal procedures in the Palestinian consulate in Turkey; 3) Violation of equality before the law; 4) Inadequate procedures by the Sharia enforcement department; 5) Police station refusal to receive a complaint; 6) Additional fees charged by a public official in violation of the law.

MUSAWA sent a legal memo to the Anti-Corruption Commission regarding the first complaint, and gave legal advice on the second complaint. In terms of the rest of the complaints, MUSAWA will meet with the Attorney General in Gaza, Dia' Al-Din Madhoun, to follow-up on these complaint.

Field Visits to the Pillars of Justice

Represented by the Legal Monitoring Officer, Adv. Rula Moussa; MUSAWA conducted a field visit to the Public and Prosecution the Human Rights Department. The representative of the organization met with the Attorney General to follow-up and address some of the complaints received MUSAWA. by Additionally, a visit was conducted to the Judicial Inspection Department in the Sharia Judiciary.

MUSAWA, UNDP, and PCBS: Legal Monitor Report 2018

Represented by its General Manager, MUSAWA participated in a workshop held at the headquarters of the Palestine Central Bureau of Statistics to discuss the participants' opinions regarding the questionnaires to survey the community perceptions on the performance of the Sixteen thousand justice system. questionnaires will be distributed to collect data for issuing the fifth Legal Monitor Report, within the framework of the joint project between MUSAWA, UNDP and PCBS .The Legal Monitor Report is MUSAWA's tool to track the changes taking place within the justice system over the years.



MUSAWA Signs MOUs with Palestinian Grassroots Organizations

Seeking cooperation for the implementation of joint activities and strengthening its relations with other parties to exchange experience in various fields, MUSAWA signed a Memorandum of Understanding (MoU) with "Not to forget" Society in Jenin Refugee Camp/ Jenin.



MUSAWA meets with the Office of the High Commissioner for Human Rights

Represented by the General Manager, Adv. Ibrahim al-Barghouthi and the Executive Manager, Ahlam Tarayra; MUSAWA participated in a meeting with the office of the High Commissioner for Human Rights in Ramallah, held on 30/07/2018. The meeting aimed at discussing scopes of joint cooperation, particularly in strengthening the capacity of MUSAWA in preparing shadow reports, revising official reports and contacting the special rapporteurs of the international agreements and treaties Palestine has acceded to, particularly the Optional Protocol of International Covenant on Civil and Political Rights aiming at the abolition of death penalty.

Earlier this month, MUSAWA participated in a meeting at the officer of the High commissioner for Human Rights, held on 03/07/2018, which aimed at examining the situation of human rights in a number of Arab countries and the role of the High Commissioner in monitoring the violations of human rights. MUSAWA was represented by the General Manager, Adv. Ibrahim al-Barghouthi and the Financial Manager, Marina Qaqish.

ICRC Visits MUSAWA

On 19/07/2018 a delegation from the International Committee of the Red Cross, represented by Ms. Amany Naour – Media and Publications Department, visited MUSAWA's office in Gaza. The meeting, which was attended by 15 people, including 5 women, brought together members from Lawyers for the Rule of Law Groups to discuss the work and objectives of the committee.

MUSAWA's Mobile Legal Clinic

Strengthening its oversight role on the performance of the justice sector and raising the awareness of marginalized groups about their rights, as well as building the capacities of young lawyers and law students, MUSAWA, alongside its volunteers' network, conducted awareness raising workshops in the West Bank (Jenin refugee camp, Kardaleh) and the Gaza Strip (Beit Hanoun, Khanyounis, Khuza'a, ad- Daraj, al Tuffah, and Jablya). During the workshops, legal advice was given mainly on matters related to Women Rights, Child Rights, Women's Access to Justice, the Personal Status Law, Sharia Rights, Marriage Terms and Procedures of Alimony suits, the Crime of Cyber Blackmailing, Inspection Procedures in the Penal Procedures Law, and Labor Rights. In both Gaza and the WB, 175 beneficiaries attended the workshops, including 140 women.
