## MUSAWA Continues to Call Duty Bearers for Assuming Responsibility for Reforming the Justice System in Accordance with MUSAWA's Vision

During its meeting with Mr. Prime Minister Dr. Mohammad Ishtayya on 2/6/2019, MUSAWA's delegation declared that the crises of the Justice System is a structural one that is not related to law itself, and affirmed that any amendments on the Judicial Authority's Act shall ensure resolving this crisis by reforming the justice system according to professional assessment methods chosen by community participation to ensure a serious and major reform, apart from any domination exercised by the executive authority.

In the same context, MUSAWA's delegation

handed Dr. Ishtayya a copy of its <u>Initiative</u> for the Unification, Reform, and Improvement of the Justice System,

which was launched earlier last year, and reminded him of a <a href="memo">memo</a> published by the center in late 2017, which was sent back then to the officials' of the justice system in both the West Bank and Gaza Strip. In his capacity as a prime minister, the delegation urged him to resolve the Joint Security Committee once and for all and to endorse the Palestinian Human Rights Defenders Declaration, which was already discussed with the Minister of Justice during earlier meetings.

MUSAWA's meeting with the Prime Minister received wide media

MUSAWA's meeting with the Prime Minister received wide media coverage, as it was aired on both Palestine channel and Maan News Agency's channel, and was reported by the official websites of the government and the prime ministry, in addition to other national newspapers. It is worth mentioning that on 9/5/2019, MUSAWA met the Minister of Justice, Dr. Mohammad Shalaldeh, to discuss the status of the Justice System, and MUSAWA's vision to overcome its crises, in addition

to discussing the need to adopt a declaration that guarantees the rights of the Palestinian human rights defenders, and the means for cooperation between the two bodies in promotion of the principles of separation between powers, the rule of law, and human rights, in adherence to the international covenants signed by Palestine . During the previous period, MUSAWA has met the Attorney General, Adv. Akram Al-Khatib, to discuss the means for cooperation between the two bodies on a professional and independent basis that preserves MUSAWA's right to monitor the justice system and thus contribute to developing and reforming it.

#### **MUSAWA's Interventions**

During June, MUSAWA received nine complaints on 1) The indictment of a lawyer and Impeding the investigation procedures before the north police center; 2) The financial fees imposed on filing a complaint with the Palestinian Bar Association; 3) The slow pace of registering the license of Peace Loving Association at the Ministry of the interior in Ramallah; 4) The failure of the main prosecution witness to appear at 2 hearings; 5) Conducting election in contradiction with the law of the medical imaging union; 6) The theft charge; 7) Two complaints on refraining from implementing a judicial ruling; 9) A police officer attacks citizens. MUSAWA has provided four legal consolations, sent a memo to the competent bodies, while one of the complaints was dropped, another one was considered none of MUSAWA's jurisdiction, and two memos are still being followed up.

#### Field Visits to the pillars of Justice

In cooperation with the Lawyers for the Rule of Law Groups (friends of MUSAWA), MUSAWA carried-out a series of field visits to the pillars of justice in the Gaza Strip, including the justice palace compound, the magistrate's court and the Court of First Instance in Khanyounes, the court of military judiciary, the Juvenile Court, the Criminal Court and the Sharia courts in Gaza. During those visits, 3 violations were documented, whereas 4 legal consultations were provided, noting that these visits come as part of MUSAWA's work as a watchdog organization that monitors law-violations and promotes the rule of law.

## **MUSAWA's Mobile Legal Clinic**

Strengthening its oversight role on the performance of the justice sector and raising the awareness of marginalized groups about their rights and the available mechanisms to attain them, as well as building the capacities of young lawyers and law students, MUSAWA, along with its volunteering groups and partner CBOs conducted 2 workshops in Gaza Strip (Hayy Al-Daraj, and Beit Lahya). The workshops addressed the following topics: children's rights according to the Palestinian constitution and international covenants, and the phenomenon of child labor in Palestine. A total of 69 participants attended the workshops, including 25 ladies. On the margins of those workshops, several legal consultations were provided for the participants.







# MUSAWA and Al-Israa University Singed a Protocol to Establish a Legal Clinic in the University



On Monday 17/6/2019, MUSAWA- The Palestinian Center for the Independence of the Judiciary and the Legal Profession and Al-Israa University have signed a protocol to establish a legal clinic at the University. In the signing meeting, MUSAWA was represented by Adv. Islah Hasaneyyeh, the BOD's member and Adv. Momen Hattab, the Legal Awareness & Training Office, while Al-Israa University was represented by Dr. Adnan Al-Hajjar, the President of the University, Dr. Alaa Matar, the dean of the Law Faculty, and Dr. Tareq Al-Dirawi, the faculty acting dean. The protocol was in

implementation of an understanding memorandum signed between the two parties a while ago, aiming at updating the legal data and applications provided for the law student, and connecting them to the practical aspects of the legal life. Under the Convention, an office inside the university shall be allocated for the legal clinic activities, such as receiving complaints, monitoring and documenting violations against the law and human rights, in addition to implementing legal awareness workshops for the students, and connecting them with training programs and moot courts that reflect the practical needs, in addition to organizing a team for the mobile legal clinic to monitor the violations committed in the marginalized areas and addressing them. This protocol also enhances the principle of partnership and participation for the sake of sharpening the students' skills to fit their future role in the legal life and to establish the principle of the rule of law according to the human rights- based approach, noting that a similar protocol was also signed with Gaza University previously.

### **MUSAWA Hosts a Workshop Implemented by PCARD**

On 22/6/2019, MUSAWA hosted a workshop on the rights of the Palestinian women, which was implemented by the Palestinian Crescent for Relief and Development in association with Palestine's Center for Studies and Research. The workshop material included topics on women's rights in Palestine as provided by laws and the constitution, and a comparison between the positive law and the personal law, those topics were presented by Adv. Basel Al-Ajez, with the attendance of 21



students and graduates, including 8 ladies. On the margins of the workshop, a discussion was opened among the participants and their inquiries about the topics were answered.



# MUSAWA Organizes An Internal Training on The Qualitative Methods of Research

On 27/6/2019, the Monitoring & Evaluation Officer, Dareen Lafi, implemented an internal training for MUSAWA's crew, on the qualitative methods of research, which include two approaches; personal interviews and focus groups. During the meeting, Lafi has identified the ways of preparing for the activities of both approaches, their importance, their procedural requirements, their target groups, the ways of moderating the dialogues and



discussions to get the needed data and achieve the goals of the research as a whole. This training is part of the preparations for implementing a study on the legal aid needs of gender based violence survivors, as well as to assess the legal help provided for them, noting that MUSAWA has signed an agreement with the Italian Development Cooperation to prepare this study/assessment.
